## RESOLUTION NO. 1 OF 2016

A RESOLUTION AMENDING RESOLUTION NO. 3 OF 2015, TO CHANGE THE EXPIRATION DATE OF UNUSED COUPONS; CONTINUING THE FIVE DOLLAR (\$5.00) FEE AND ELIGIBILITY REQUIREMENTS FOR ISSUANCE TO HOUSEHOLDS DESIRING THE SAME OF COUPONS FOR DISPOSAL OF HOUSEHOLD WASTE AT THE REPUBLIC SERVICES LANDFILL FORMERLY KNOWN AS THE SALINE COUNTY LANDFILL UP TO TWO (2) DAYS PER YEAR WITHOUT PAYING GATE CHARGES OR TIPPING FEES AND, FOR OTHER PURPOSES

WHEREAS, The Saline County Regional Solid Waste Management Board (hereafter, the "Board") is authorized and empowered by the Arkansas Code, and specifically by ACA § 8-6-704(a)(6), to take the actions set out in this Resolution; and,

WHEREAS, On April 15, 2015, the Board adopted its Resolution No. 3 of 2015 establishing a fee of Five Dollars (\$5.00) for the issuance of coupons for qualified resident households in Saline County as eligible for disposal of household waste at the Republic Services Landfill formerly known as the Saline County Landfill without payment of gate charges or tipping fees up to two days per year; and,

WHEREAS, Coupons are available to Saline County residents beginning on the first business day of each year and are valid until expiration, pursuant to Resolution 3 of 2015 (2), which reads in pertinent part:

“All unused coupons shall expire at the close of business at the Republic Services Landfill on the last business day of the year for which the said coupons are issued;” and,

WHEREAS, The Board has found and determined that the year-end expiration date of unused coupons causes undue burdens on both the Republic Services Landfill and District staff. On-going improvements at the landfill and well as staffing realities during the December holiday season at both the District Office and the Republic Services Landfill require the alteration of the expiration date for unused coupons; and,

WHEREAS, It is appropriate, fair and reasonable to establish an earlier expiration date for landfill coupons for households in Saline County; and,

WHEREAS, Pursuant to thirty (30) days’ public notice given in accordance with ACA § 25-15-204 the Board has conducted a Public Hearing on August 17, 2016, and has solicited comments from the public regarding the substance of this Resolution; and,

WHEREAS, The Board has considered all public comment and other information presented to it and has determined that taking the action set out herein is in the best interest of the Saline County Regional Solid Waste Management District and is in the best interest of the persons and entities served by the District;

NOW, THEREFORE, BE IT RESOLVED by the Saline County Regional Solid Waste Management District that:



SECTION 1: *Coupon Fee Continued.* The District shall continue, as established by the District's Resolution No. 3 of 2015, to charge a fee of Five Dollars (\$5.00) per household for the issuance of coupons to identify each household requesting the same as being eligible for two (2) days of disposal at the Republic Services Landfill formerly known as the Saline County Landfill.

SECTION 2: *Limitation on Coupons.* Each household located in the District which shows current documentation that the household has its trash collected by a licensed Saline County trash hauler or shows sufficient documentation that it is otherwise disposing of its solid waste through the services of a licensed Saline County trash hauler shall be entitled to one (1) issuance of two (2) coupons per calendar year. Each coupon shall identify the household to which it is issued as eligible for one (1) admission to the Republic Services Landfill formerly known as the Saline County Landfill for disposal of household waste. All unused coupons shall expire at the close of business at the Republic Services Landfill formerly known as the Saline County Landfill on the last business day of November of the year for which the said coupons are issued.

SECTION 3: *Repealer.* This Resolution amends Resolution No. 3 of 2015 which shall remain in full force and effect except to the extent specifically set out in this Resolution. All other Resolutions of the

Board and parts thereof in conflict with the provisions of this Resolution are, upon the effective date of this Resolution, repealed to the extent of such conflict, but not otherwise

SECTION 4: *Effective Date.* The effective date of this Resolution shall be August 17, 2016, and the requirements of this Resolution shall be applicable to the District Coupon Program from and after January 1, 2016.
